


## WIDENING INSTRUMENTS

- Support to Widening countries in H2020 (2014-2020) for the 1st time in EU FP
- Widening countries must be coordinators
  - three basic instruments: TEAMING, TWINNING and ERA Chairs, complemented by COST programme and Widening Fellowships (MSCA)
- Continuation in HORIZON EUROPE (2021-2027) new elements and instruments
- Specific package of measures Advancing Europe:
  - horizontal part Widening Participation and Spreading Excellence
  - targeted measures across HORIZON (Hop On Facility, Matchmaking, Proposal Review, Recognition of Participation)




## **ADVANCING EUROPE PACKAGE**

## **HOP ON FACILITY**

- Proposal must be submitted by the coordinator of a consortium funded under HORIZON Pillar 2 with a valid grant agreement without any participant from a Widening country (project type: RIA)
- Proposal must include the accession of one additional partner from a Widening country
- Opening: 4 January 2022; Deadlines: 20 April 2022 and 10 November 2022
- Overall indicative budget: M€ 40; EU budget per project: M€ 0,2 – 0,5
- Expected no. of projects: 80



## **RECOGNITION OF PARTICIPATON**

 Certificate for coordinators from Widening Countries

 On request – issued by the EC after the completed implementation of the project or after successful mid term review



## **MATCHMAKING**

- Benchmark of existing matchmaking tools and possible top-up
- Synergies with existing platforms, e.g. Funding & Tenders Portal and EURAXESS
- Joint Brokerage Events with clusters (Pillar II) systematic approach in implementing Widening calls into BE agenda; bringing applicants from Widening countries to BE
- Study visits of Widening applicants to advanced partners – mutual learning (e.g. research management) + matchmaking



## PROPOSAL REVIEW / CHECK

- Transnational and national seminars dedicated to proposals writing for applicants in Widening Countries
- Pre-screening standards and best practices materials, guides, training plans for applicants
- Trainings on Widening issues dedicated to Pillar II applicants





## **WIDENING AND ERA: RATIONALE**

#### **WIDENING PART**

Significant disparities of R&I performance within the EU and low participation os some countries in FPs due to:

- reduced access to international networks
- system learning effects
- problems with information, communication and training
- insufficient national R&D investments
- lack of synergies between national research systems and EU research landscape

#### **ERA PART**

Reforming and enhancing the EU R&I system - calls structured around 4 strands corresponding to 4 objectives of the new ERA:

- 1. Prioritise investments and reforms
- 2. Improve access to excellence
- 3. Translate R&I results into the economy
- 4. Deepening the ERA
- principle of excellence remains the cornerstone for all investments under ERA

- Underpin geographical diversity and build the necessary capacity to allow successful participation in the R&I process
- Foster brain circulation across ERA through mobility of researchers and innovators, to address current imbalances
- Improve research management capacities
- Deepen the ERA
- Reinforce the interaction between education and research by dissemination and exploitation of research results
- Strengthen collaborative links across EU and open up European R&I networks

## **NEW ELEMENT – ELIGIBILITY OF R&I COSTS**

Regulation establishing HORIZON, Article 2 – Definitions, paragraph (25h)

"coordination and support action" means an action contributing to the objectives of the HORIZON programme, excluding research and innovation activities, except when undertaken under the component "widening participation and spreading excellence" of the part "Widening Participation and Strengthening the ERA"; ...

Research and innovation costs are eligible in CSA for Widening instruments

## **PROPOSAL RANKING**

- In the first place, ex aequo proposals will be prioritised according to geographical diversity criterion with the aim to better spread the impact of the projects and to strengthen the efficiency of the Widening instruments
- This procedure is valid for TEAMING, TWINNING, ERA Chairs and Excellence Hubs, not foreseen for EEI as not so many applications are expected

## **TEAMING FOR EXCELLENCE**

#### **RATIONALE**

- MAIN AIM -- institution building: create new centres of excellence or substantially upgrade existing ones (2 phases abolished)
- Two-stage evaluation process (more details in FAQs)
- Complementary funding from other sources at least equal to the requested HORIZON grant (letter of commitment for the 2nd stage)
- Seals of Excellence to applications exceeding all of the evaluation thresholds but cannot be funded due to lack of budget available
- A research component up to 10% may include preparatory research project

- Opening: 8 June 2021
- Deadline 1st stage: 30 September 2021
- Deadline 2nd stage: 20 April 2022
- Overall indicative budget: M€ 180

## **TWINNING**

#### **RATIONALE**

- MAIN AIM -- institutional networking to enable:
  - Transfer of knowledge and skills and exchange of best practices
  - Raising of research profile of the institution and its staff
  - Special focus on strengthening the research management and administrative skills
- A research component up to 30% may include exploratory research project (dedicated WP) - at least 70% of the research activities must be allocated to the coordinator

- Opening: 15 June 2021
- Deadline: 21 December 2021
- Overall indicative budget: M€ 149
- Budget per project: M€ 0,8 1,5
- Project duration: up to 3 years

## **TWINNING WESTERN BALKANS**

#### **RATIONALE**

- MAIN AIM -- institutional networking
- Eligible countries: Albania, Serbia,
   Montenegro, Bosnia and Herzegovina, North
   Macedonia and Kosovo
- A research component up to 30% may include exploratory research project (dedicated WP) - at least 70% of the research activities must be allocated to the coordinator
- Czech institutions can be advanced partners
   be proactive

## **EUROPEAN EXCELLENCE INITIATIVE - NEW**

#### **RATIONALE**

- MAIN AIM -- capacity building to strengthen networks of HEIs and cooperation with surrounding ecosystems
- Inclusion of research activities in with a centre of gravity in widening countries
- Preparing for the full roll-out of the European Universities initiative (pending the evaluation of European Universities pilot)
- At least 2 HEIs from Widening country (or different WCs) and at least 2 internationallyleading institutions from 2 different MS or AC
- Entities benefiting from the European Universities initiative pilot funding of H2020 can participate but are excluded from funding

### **ERA PART – COMMON ELEMENTS**

- Topics support creation of a single, borderless market for research, innovation and technology across the EU
- Principle of excellence remains the cornerstone for all investments under the ERA
- Common opening date (8 June 2021, 19 January 2022) and deadline (23 September 2021, 20 April 2022) for all ERA calls
- Project duration usually not set; Project types: CSA or RIA

### **ERA PART – STRUCTURE**

- Reforming and enhancing the EU R&I system calls structured around 4 strands corresponding to the four objectives set out in the new ERA Communication (09/2020):
  - 1. Prioritise investments and reforms in R&I to support the digital and green transition and Europe's recovery
  - 2. Improve access to excellent R&I for researchers across the EU
  - 3. Translate results into the economy to ensure market uptake of research output and Europe's competitive leadership in technology
  - 4. Deepening the ERA (make progress on the free circulation of knowledge, researchers and technology through stronger cooperation with EU countries)

- Improve training and skills development of RM staff
- Develop better RM capacity and guidance for researchers across ERA

- Active involvement of entities located in widening countries is expected
